



### SEADREAM YACHT CLUB TRAVEL AFFIDAVIT

I understand that the Office of Foreign Assets Control of the U.S. Department of the Treasury ("OFAC") administers and enforces the Cuban Assets Control Regulations ("CACR").<sup>1</sup> I further understand that the CACR prohibits U.S. persons from engaging in travel transactions and from travelling to Cuba, unless they qualify for a general license.<sup>2</sup> I have reviewed the CACR and/or OFAC's guidance on the travel restrictions.<sup>3</sup>

I, the undersigned, declare and certify that (a) I am subject to U.S. jurisdiction and (b) I qualify for a general license, as marked below. I further confirm that as a licensed traveller, I am obligated to retain all records relating to my travel to Cuba for a period of five years.
